Motion by McGregor and 2<sup>nd</sup> Besch that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Windstream Communications, Inc, Emmetsburg, IA, to install new telephone cable. Work will consist of placing 66' of 2 pair copper telephone cable across 390<sup>th</sup> Street approximately 1,175' west of 40<sup>th</sup> Avenue. The work will be in Sections 4 and 9 Seneca Township. Permit number 04-03-2014 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Tjarks and 2<sup>nd</sup> by Plathe to approve the Iowa Department of Transportation detour agreement for the use of Kossuth County routes P30 and A16 for the time period of April 28, 2014 to May 9, 2014. Description of the detour route is: Fro, the junction IA9 and P30 at Swea City, thence north 7 miles to the junction of A16 and P30 north of Swea City thence east 7.0 miles on A16 to the junction of A16 and US169 south of Elmore, Minnesota. Motion carried.

## **RESOLUTION #04-22-14-01**

WHEREAS Kossuth County recognizes the hazards caused by exposure to environmental tobacco smoke, as well as the life-threatening diseases linked to the use of all forms of tobacco; AND

WHEREAS Kossuth County attempts to earn the understanding, goodwill, and respect of the communities in all of Kossuth County, and that sound community relations helps to establish and foster trust and respect between the County and all of its neighbors, for the benefit of all.

THEREFORE BE IT RESOLVED that the Kossuth County Board of Supervisors hereby declares the Kossuth County Courthouse and all County property to be Tobacco Free Worksites for all employees and visitors. No person shall be allowed or permitted to smoke any tobacco product or use oral tobacco products or "spit" tobacco, and this policy applies to all employees and non-employee visitors to the county property.
