WHEREAS, not having a full-time Kossuth County Department of Human Services office in Algona, Iowa, and having the proposed closest Iowa Department of Human Services office in Estherville, Iowa, would impose a hardship on the citizens of Kossuth County and potentially a denial of services; and

WHEREAS, the closing of the Kossuth County Iowa Department of Human Services office does not present a cost savings to the Iowa Department of Human Services; and

WHEREAS, the Kossuth County Board of Supervisors want to formally express and adopt their collective disapproval of any plan that involves the closing of the Iowa Department of Human Services office in Kossuth County, Iowa.

NOW THEREFORE BE IT RESOLVED that the Kossuth County Board of Supervisors hereby proclaims publically their collective disapproval of any plan to close the Iowa Department of Human Services office in Kossuth County, Iowa.

IT IS FURTHER RESOLVED that the Kossuth County Board of Supervisors hereby recommends to the Iowa Department of Human Services to abandon its plan to close the Kossuth County Iowa Department of Human Services office.
