Motion by Wymore and 2nd by Besch to approve the first reading of the amendment of Ordinance #422 (formerly #22) which is the Abatement of Nuisances in Kossuth County. Chairman McGregor called for a roll call vote. Besch: yes, Elsbecker: yes, Plathe: yes, Wymore: yes and McGregor: yes

Motion by Plathe and 2nd by Elsbecker to accept the bid from Stephens Communications in the amount of \$48,272.19 for the Courthouse/LEC/Annex Telephone system and to authorize the Chairperson to sign the contract upon its arrival. Motion carried.

Motion by Besch and 2nd by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Algona Municipal Utilities, Algona, IA, to install communication services to a residence. Work will involve boring from a pedestal on the north side of 200th Street (Orton Road), boring south and east to residence. The work will be between Sections 15 and 10 Cresco Township, 1012 200th Street. Permit number 08-29-2012 is on file in the Kossuth County Engineer's Office. Motion carried.
