Work will involve maintenance work on overhead lines on 210<sup>th</sup> Avenue, 230<sup>th</sup> Avenue and 200<sup>th</sup> Street. Work will be in Section 9, 10, 11, 15, 16, and 17, Prairie Township. Permit number 12-35-2014 is on file in the Kossuth County Engineer's Office. Motion carried.
