WHEREAS, Section 306.41 of the Code of Iowa provides for the temporary closing of sections of roadway when necessary because of construction, and

WHEREAS, the County Engineer has been authorized by a previous resolution of this Board of Supervisors to execute the requirements of Section 306.41 regarding temporary road closures, and

WHEREAS, road resurfacing projects FM-CO55(145)--55-55, located on C-12 from LuVerne east 5.5 miles to Highway #17, and project FM-CO55(144)--55-55, located on B-19 from P-54 east 9 miles to R-14, and project LFM-RS14(3)--7X-55, located on B-14 from P-20 east 8 miles to Highway #169, be closed to all traffic, and

NOW THEREFORE, BE IT RESOLVED, by the Kossuth County Board of Supervisors that the above-described road be closed and proper signs be erected for the duration of the construction project as determined by the County Engineer.

BE IT FURTHER RESOLVED, that upon completion of the construction work, as determined by the County Engineer, the road shall be opened to the traveling public without further action of this board.
