Motion by Besch and 2<sup>nd</sup> by Wymore to approve the purchase of Tiger Heavy Duty 60" side and 60" rear mounted rotary mowers at the installed price of \$25,824.82 and to approve the purchase of JD 7130 Tractor from Ernie Williams, Algona at the after trade price of \$31,870.00. Ayes 5, Nays 0. Roll Call Vote: Besch yes, Elsbecker yes, McGregor yes, Wymore yes, Plathe yes. Motion carried unanimous.

Motion by Elsbecker and 2<sup>nd</sup> by McGregor to approve purchase of ATV for Secondary Road for checking tile, spraying and seeding. Ayes 4, Nays 1. Roll Call Vote: Besch no, Elsbecker yes, McGregor yes, Wymore yes, and Plathe yes. Motion carried.

Motion by McGregor and 2<sup>nd</sup> by Elsbecker that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, Estherville, IA, to replace and install a new three phase underground cable in the road right of way of 10<sup>th</sup> Avenue and 390<sup>th</sup> Street (southwest corner of section 6, Seneca Township) and run north approximately 1/2 mile north, from Highway 15 east on 350<sup>th</sup> Street in Section 6, Seneca Township. Permit number 08-06-21 is on file in the Kossuth County Engineer's Office. Ayes 5, Nays 0. Motion carried unanimous.
