Motion by Elsbecker and 2nd by McGregor to approve the Matrix for #65109, located in SW ¼ SE ¼ Section 31, Greenwood Township, Hogs-R-Us, LLC (Patrick Fisher) and sign letter of approval. Ayes 5, Nays 0. Motion carried unanimous.

Scott Curtis was unable to attend due to hospital obligations and will send review of Kossuth County Hospital report.

Motion by Wymore and 2nd by Besch to approve and authorize the chair to sign the contracts and bonds of Midwest Contracting, LLC of Marshall, Minnesota, for box culvert construction for the following project: L-C573205-- 73 – 55 \$88,625.00. Ayes 5, Nays 0. Motion carried unanimous.

Motion by Elsbecker and 2nd by McGregor that the Board of Supervisors of Kossuth County, Iowa does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, Estherville, Iowa, to provide new two V-phase, 12470/7200 volt overhead power line with poles, anchors and 1/0 ACSR conductor service to a bin site. Work will be on east side 220th Avenue beginning at the intersection with 420th Street crossing south over 420th Street and then going south ¾ mile in Section 22 and 27 Lincoln Township. Permit number 07-03-03 is on file in the Kossuth County Engineer's Office. Ayes 5, Nays 0. Motion carried unanimous.

Motion by McGregor and 2nd by Elsbecker, that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, Estherville, IA, to install new

single phase conductor at a voltage of 7200 volts with one pedestal to a bin site. Work will be boring under 220th Avenue approximately ¾ mile south of 420th Street, Section 27 and 28 Lincoln Township. Permit number 07-03-04 is on file in the Kossuth County Engineer's Office. Ayes 5, Nays 0. Motion carried unanimous.
