To help youth better understand that Kossuth County is a wonderful place to grow, be educated and develop into a productive quality adult.

WHEREAS, the money to the Kossuth County Community Foundation, main goals are to serve the people improving the quality of life in Kossuth County and to promote philanthropy and attract additional funds to assist donors in creating lasting legacies in all areas, Arts and Culture, Community Affairs and Development, Education, Environmental Education and Protection, Health, Historic Preservation and Human Services.

WHEREAS, the money in the budget for the YMCA is to support programs which teach values in honesty, caring, respect, and responsibility. The goals of the YMCA are to strengthen families, help form positive values, and develop leadership.

**WHEREAS**, the money in the budget for Bill Finn House Inc. and the Swea City Assisted Living is to increase and improve the services to the citizens of Kossuth County.
