Motion by Froehlich and 2nd by McGregor to adopt budget as presented.

Motion by Besch to amend the motion to adopt budget and to not appropriate money to Economic Development until an accountability of their expenditures have been received by the board. No second to motion.

Back to motion by Froehlich and 2nd by McGregor to adopt budget as presented. Roll Call Vote: Plathe yes, McGregor yes, Froehlich yes, Besch no, Elsbecker yes. Ayes 4, Nays 1 Motion carried.

Whereby the Board of Supervisors of Kossuth County held a Public Hearing as required by law on the 14th day of March, 2005, 1:00 p.m. for the Budget year 07-01-05 to 06-30-06, and was adopted as summarized, published and attached hereto, and tax levies voted on all taxable property of the County.
