Discussion was held with Kossuth County Attorney, Todd Holmes and Kossuth County Recorder, Karen Benschoter in regards to an ATV Ordinance for Kossuth County.

Motion by Wymore and 2nd by Plathe to create a night-time Sergeants position at 78% of the Sheriff's Wage. Motion carried.

Motion by Wymore and 2nd by Plathe to appoint Steve Bode as Plum Creek Township Trustee to a 2 year term expiring December 31, 2016. Motion carried.

The Board of Supervisors were provided copies of the February transfers that Kossuth County Auditor, Amber Garman made on March 5, 2015 from the General Basic Fund to the Secondary Road Fund in the amount of \$1974.89 and from the Rural Basic Fund to the Secondary Road Fund in the amount of \$18231.88.

Motion by Tjarks and 2nd by Plathe that the Board of Supervisors of Kossuth County, Iowa does hereby authorize and give its permission to Alliant Energy, Mason City, IA, to complete overhead power pole and line maintenance. Work will involve maintenance on existing power poles along various locations in the right of way. Work will be completed in:

Plum Creek Township: 160th Avenue, Section 27 170th Avenue, Section 23 190th Avenue, Section 25 240th Street, Sections 22, 23 and 24

Motion by Besch and 2nd by McGregor that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, Estherville, IA, to upgrade an existing overhead line to underground. Work will involve boring a cased cable under 120th Avenue, approximately 1,215' south of 490th Street, between Sections 23 and 24 Grant Township. Permit number 03-03-2015 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by McGregor and 2nd by Besch that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Lakes Electric Cooperative, Estherville, IA, to upgrade an existing overhead line to underground. Work will involve boring a cased cable under 380th Street, approximately 675' west of 130th Avenue, between Sections 12 and 13 Greenwood Township. Permit number 03-04-2015 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Tjarks and 2nd by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to EC Source Services LLC, Story City, IA, to install a temporary guard structure. The structure will protect the distribution line of any accidental contact. Work will be on the NE corner of 165th Avenue and 250th Street, Section 15, Plum Creek Township. Permit number 03-05-2015 is on file in the Kossuth County Engineer's Office. Motion carried.
