Motion by Besch and 2<sup>nd</sup> by McGregor to open public hearing for James Vaske, Section 20 of Ramsey Township (Cogley Site). Ayes 5, Nays 0. Motion carried unanimous.

No negative letters or contest to Vaske hearing.

Motion by McGregor and 2<sup>nd</sup> by Elsbecker to close public hearing for James Vaske, Section 20 of Ramsey Township (Cogley Site). Ayes 5, Nays 0. Motion carried unanimous.

Motion by McGregor and 2<sup>nd</sup> by Wymore to approve the Kossuth County Secondary Road Department Fiscal Year 2009 Budget and five year construction program and to recommend approval to the Iowa Department of Transportation. Roll Call Vote: Elsbecker yes, McGregor yes, Besch yes, Wymore yes, and Plathe yes. Motion carried unanimous.

Motion by McGregor and 2<sup>nd</sup> by Besch to authorize the chairman of the Kossuth County Board of Supervisors to sign the Quit Claim Deed for sale of property located in the SE ¼ of the NW ¼ of Section 8, T-98-N, R-30-W, Seneca Township, containing 4.73 acres to Andrew J. Bernhard. Ayes 5, Nays 0. Motion carried unanimous.

Motion by Elsbecker and 2<sup>nd</sup> by McGregor to authorize the chairman of the Kossuth County Board of Supervisors to sign the Warranty Deed for sale of property located in the S ½ of the NW ¼ of Section 34, T-97-N, R-27-W, and also that part of the North ½ of the NW ¼ Section 34, T-97-N, R-27-W, Buffalo Township, containing 82.2 acres to Bruce and Mary Kae Hanson. Ayes 5, Nays 0. Motion carried unanimous.

Motion by McGregor and 2<sup>nd</sup> by Elsbecker to table as paper work was not in for the North Kossuth Golf Club liquor permit. Ayes 5, Nays 0. Motion carried unanimous.
