of an Animal Confinement Feeding Operation

Motion by McGregor and 2<sup>nd</sup> by Besch to approve the liquor license for Plum Creek Winery. Motion carried.

Motion by Tjarks and 2<sup>nd</sup> by Besch to approve B & W Control Specialists, Inc., quote of \$74780 for roadside weed control for 2013 which is on file in the County Engineer's Office. Motion carried.

Motion by McGregor and 2<sup>nd</sup> by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Mike Riggert, Algona, IA, to install 2 new drain tiles under 40<sup>th</sup> Avenue and 1 new drain tile under 270<sup>th</sup> Street. The first crossing will involve excavating a trench and installing a 18" tile under 40<sup>th</sup> Avenue, approximately 600 feet north of the intersection of 270<sup>th</sup> Street and 40<sup>th</sup> Avenue between Section 3 and 4 of Lotts Creek Township. The second crossing will involve excavating a trench and installing a 15" tile under 40<sup>th</sup> Avenue, approximately 475 feet south of the intersection of 270<sup>th</sup> Street and 40<sup>th</sup> Avenue, between Section 9 and 10 of Lotts Creek Township. The third crossing will involve excavating a trench and installing a 24" tile under 270<sup>th</sup> Street, approximately 900' east of the intersection of 270<sup>th</sup> Street and 40<sup>th</sup> Avenue. Permit number 3-06-2013 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Tjarks and 2<sup>nd</sup> by Besch to deny the requests of Burt United Methodist Church to reimburse amount paid by them the first half of property taxes for the FY 12-13 and to deny removing the property from the tax rolls. Motion carried.

Drainage was held followed by Discussion with Kossuth County Auditor and Board Discussion and Committee Reports.
