Motion by Plathe and 2nd by Elsbecker to approve the Matrix for Hawkeye 12, and General Development LLC in Plum Creek Township, Section 36 with 490 points. Ayes all, Nays none. Motion carried unanimous.

Motion by Besch and 2nd by McGregor to approve Resolution 05-09-06-01 to adopt weed policy for weed commissioner, Ken Mulligan. Ayes all, Nays none. Motion carried unanimous.

RESOLUTION # 05-09-06-01

Motion by Besch and seconded by McGregor to approve the following resolution.

WHEREAS; Chapter 317.13 of the Code of Iowa requires that each year the Board of Supervisors prescribe and order a program of weed destruction to be followed by landowners and tenants.

WHEREAS; it is the recommendation of the Kossuth County Weed Commissioner that the following weed policy be adopted.

NOW THEREFORE BE IT RESOLVED by the Kossuth County Board of Supervisors to adopt the following noxious weed policy for all Kossuth County landowners and tenants:

NOXIOUS WEED POLICY

Notice is hereby given this 9th day of May, 2006, pursuant to the Code of Iowa, Chapter 317, Weed Law. All owners, occupants, agents, and public officials in charge of lands in Kossuth County shall destroy or eradicate noxious weeds standing, being, or growing on such lands by effective cutting, tillage, cropping, or treating with chemicals or combination thereof, **as often as may be required to prevent the weeds from blooming and maturing seeds.**

GROUP 1 - by June 5 - Leafy spurge, Hoary cress, Sour Dock, Smooth dock, Red Sorrel, Musk thistle, Buckthorn.

GROUP 2 – by June 16 - Canada thistle, Russian knapweed, Buckthorn plantain, Wild mustard.

GROUP 3 – by July 15 - Field bindweed, Wild carrot, Poison hemlock, Multiflora rose, Horsenettle, Sowthistle, Quackgrass, Velvetleaf, Puncture vine, Cocklebur, Bull thistle, Tall thistle, Wild sunflower, Teasel, and all other thistles of the Circium or Carduus genus, Shattercane and Purple Loosestrife.

Upon failure to observe this notice, the Weed Commissioner is required to proceed pursuant to the law and have the weeds destroyed, the expense of which shall constitute a lien and be entered as a tax against the land and be collected as other real estates taxes are collected.

Motion by Besch and 2nd by Plathe that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Humboldt County Rural Electric Cooperative, Humboldt, IA, to remove overhead line and install new underground electric cables to serve power to grain bins. The trenching will cross

270th Street from Section 12 to Section 1, Wesley Township. Permit number 06-05-15 is on file in the Kossuth County Engineer's Office. Ayes all, Nays none. Motion carried unanimous.

Motion by Froehlich and 2nd by Elsbecker that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Algona Municipal Utilities, Algona, IA. To bore new 2" conduit underground electric service to new residence. The boring will cross Call Park road at the north edge of 1906 Call Park Road in Section 14 Cresco Township. Permit number 06-05-16 is on file in the Kossuth County Engineer's Office. Ayes all, Nays none. Motion carried unanimous.

Motion by Froehlich and 2nd by McGregor that the Board of Supervisors of Kossuth county, Iowa, does hereby authorize and give its permission to Deb Specht, Algona, IA, to construct a tile outlet in the road right of way. The tile outlet is located in the southeast quarter of Section 10, Cresco Township approximately 1400 feet east of the S ¼ corner of section 10, in the north road ditch of Orton Road, approximately 200 feet east of the intersection of Woodlyn Hills entrance and Orton Road. Permit number OT-06-05-01 is on file in the Kossuth County Engineer's Office. Ayes all, Nays none. Motion carried unanimous.

Motion by Elsbecker and 2nd by Besch that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Joe Garman, Algona, IA, to construct a tile outlet in the road right of way. The tile outlet is located in Lot 8 Block 1, Royal Oaks Subdivision, Section 14, Cresco Township, approximately 300 feet northeast of the intersection of Royale Oaks Subdivision's North Entrance and Call Park Road. Permit number OT-06-05-02 is on file in the Kossuth County Engineer's Office. Ayes all, Nays none. Motion carried unanimous.

Kossuth County Health Insurance Quarterly Report was given by Trish Casey with no increase. Motion by McGregor and 2nd by Besch to sign the Renewal Agreement with Wellmark. Ayes all, Nays none. Motion carried unanimous.
