FARM TO MARKET REVIEW BOARD APPLICATION

RESOLUTION # 11-03-08-01

Whereas; a county may apply for modifications to its farm-to-market system to add or subtract mileage from its system, to accept or delete highways gained or lost through jurisdictional transfers, or to change the classification of roads within its system, and

Whereas; the Board of Supervisors of Kossuth County has consulted with the County Engineer and desires to modify its farm-to-market road system to provide continuity of intracounty and intercounty routes, to meet the needs of existing or potential traffic, to better meet land use needs, or provide a more suitable location for a farm-to-market route, and

Whereas; application for modifications to any county's farm-to-market system must be made to the Farm-to-Market Review Board per the requirements of Iowa Code Section 306.6,

Now therefore be it resolved by the Board of Supervisors of Kossuth County that Kossuth County is formally requesting that the Farm-to-Market Review Board approve the following modifications to its farm to market system:

ROUTES TO BE ADDED TO THE FARM TO MARKET SYSTEM

1. 0.66 miles on P-60 Extension from Garfield St. in LuVerne, IA south 0.66 miles to C-12

TOTAL 0.66 miles to be added to Farm to Market System

ROUTES TO BE DELETED FROM THE FARM TO MARKET SYSTEM

- 1. 0.66 miles on Dewitt Street in LuVerne, IA from C-12 North to Garfield Street.
- 2. 0.26 miles on Garfield Street in LuVerne, IA from DeWitt Street west to P-60

TOTAL 0.92 miles to deleted from the Farm to Marker System
