

BOARD PROCEEDINGS
November 12, 2013
REGULAR NOVEMBER SESSION

The Board of Supervisors met pursuant to adjournment. Present were: Jack Plathe, Chairman Don McGregor, Don Besch, Roger Tjarks and Pam Wymore.

Public Discussion was held followed by discussion with Secondary Road Foreman.

Motion by Besch and 2nd by Tjarks to approve the agenda and the minutes of the previous meeting dated November 5, 2013. Motion carried.

The Board of Supervisors acknowledged transfers made by Kossuth County Auditor, Amber Garman on November 5, 2013 from General Basic to Secondary Road in the amount of \$31,656.73 and from Rural Basic to Secondary Road in the amount of \$337,281.91.

Motion by Tjarks and 2nd by McGregor to approve the transfer application for North Kossuth Golf Club to the Armory for December 13, 2013 through December 15, 2013. Motion carried.

Motion by McGregor and 2nd by Wymore to approve the design service agreement with Cannon Moss Brygger Architects for preliminary design of a storage facility at the Secondary Road Department Mechanic's Shop. Motion carried 4 to 1 (Besch being the NO vote.)

Motion by McGregor and 2nd by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Enventis Telecom, Inc. Mankato, MN, to install cable for maintenance repair. Work will begin in the west right of way of 170th Avenue, south of the intersection of 390th Street, then bore under 170th Avenue. Work will continue with plowing along the south right of way of 390th Street for approximately 1,401' and then bore under 390th Street to pedestal in the north right of way of 390th Street. Work will be in Section 10, 11 and 2, Ramsey Township. Permit number 11-57-2013 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Tjarks and 2nd by McGregor that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Warren Waltman, Algona, IA, to connect to an existing 6" drain tile located in the north shoulder of 240th Street about 70 feet east of Plum Creek Road (140th Street). Work will be in Section 20 of Plum Creek Township. Permit number 11-58-2013 is on file in the Kossuth County Engineer's Office. Motion carried.

Discussion with Kossuth County Engineer was held.

Motion by Wymore and 2nd by Besch to approve the quote for \$12,557.00 from Custom Countertops & More for Hanstone Quartz Countertops for the Offices of Recorder, Auditor, Assessor, Clerk of Court and Treasurer. Motion carried.

Drainage was held followed by a Completion Hearing for Joint Drainage District No. PAK #1 Lateral M.
