City of Titonka explained to the Board of Supervisors that they are interested in amending their City TIF District to include the Titonka School Building.

The Board of Supervisors acknowledged the letter from the City of Titonka in regards to the Buffalo Township Urban Renewal. The letter is a requirement of the agreement to be submitted every October 1st.

Motion by Plathe and 2nd by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Oak Hill Consulting, Inc. Burnsville, MN on behalf of Long Lines, LTD, Sergeant Bluff, IA, to install 48 fiber optic cable. The work will involve boring and plowing cable along gravel roads and in shoulder of paved roads. Work will be in the county right of way:

East side of 140th Avenue, Sections 32,29,20,17,8,5

Irvington Township:

East side of 140th Avenue, Sections 32,29,20,17,8,7

North side of 210th Street, Section 6

Whittemore Township:

South side of 210th Street, from Whittemore City limits to 10th Avenue, Section 7

East side of 20th Avenue, Sections 8,17,20,29,32

Garfield Township:

East side of 20th Avenue, Sections, 5,8,17,18

Permit number 10-29-2014 is on file in the Kossuth County Engineer's Office. Motion carried.

Drainage was held followed by the Annual Report of IDDA, Formal Hearing on Drainage District PAK #1 Lat #48 and Completion Hearing on Drainage District #39.
