Motion by Besch and 2nd by Froehlich that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Erpelding Excavating Enterprises, Algona, Iowa on behalf of Martin Kramer to install 8" N12 smooth wall plastic across 110th Avenue, Section 15 of Riverdale Township, as per agreement and permit number 04-10-32 on file in the Kossuth County Engineer's Office. Motion by Cink and 2nd by Elsbecker that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Randy Faber, Algona, Iowa, to install 1¼ inch plastic waterline under 160th Street, Section 5 of Riverdale Township and Section 32 Cresco Township, as per agreement and permit number 04-10-33 on file in the Kossuth County Engineer's Office. Motion by Elsbecker and 2nd by Cink that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Randy Faber, Algona, Iowa, to install 24" corrugated metal pipe for transporting hog manure under the roadway, crossing 160th Street between Sections 5 of Riverdale Township and Section 32 Cresco Township, as per agreement and permit number MP 04-10-02 on file in the Kossuth County Engineer's Office.
