Motion by Besch and 2nd by Plathe that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Leland Metzger, Elmer Steir and Fred Schmidt, Whittemore, IA, to cross 20th Avenue or P-16. Work will involve boring a 16" steel tile under 20th Avenue between Sections 19 and 20 Whittemore Township. Permit number 06-10-45 is on file in the Kossuth County Engineer's Office.
