Motion by Besch and 2<sup>nd</sup> by Wymore to appoint Richard Deitering, LeRoy Weber and Eugene Elsbecker to the Magistrate Nominating Commission for six year term. Motion carried.

Discussion with Kossuth County Engineer was held followed by Drainage and a Completion Hearing for Drainage District 4 Lateral 4.

Discussion was held in regards to the Memorandum Agreement between US Fish and Wildlife Service, Kossuth County and Dennis Lappe for Maynard Reece WPA. Decision will be made at a later date.

Discussion was held with the Mayor and City Administrator of Bancroft in regards to financial support for the paving of Summit Avenue. Further discussion will be held during the budget planning sessions.

Motion by Wymore and 2<sup>nd</sup> by Tjarks to approve the quarterly reports for the Kossuth County Auditor, Recorder, Sheriff and Veteran Affairs. Motion carried.

Motion by Plathe and 2<sup>nd</sup> by Wymore to approve the Annual Financial Report for FY 2013/2014 as prepared, presented and published by the Kossuth County Auditor. Motion carried.
