Public discussion and committee reports were held.

Motion by Besch and 2nd by Wymore to open the Public Hearing regarding Charlie Kollasch Construction, Section 7, LuVerne Township. Ayes 5, Nays 0. Motion carried unanimous. Five people spoke from the public and one letter was received.

Motion by McGregor and 2nd by Besch to close the Public Hearing, Charlie Kollasch Construction, Section 7, LuVerne Township. Ayes 5, Nays 0. Motion carried unanimous.

Motion by Elsbecker and 2nd by Plathe to approve the sale of the Caterpillar 816F Compactor located at the Kossuth County Landfill for the high bid of \$171,366 received from Marcel Equipment Limited, Ontario, Canada. Proceeds from the sale to be deposited in the Kossuth County Landfill Fund. Ayes 5, Nay 0. Motion carried unanimous.

Motion by McGregor and 2nd by Elsbecker that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Iowa Telecommunications Services, Inc., Emmetsburg, IA, to bore 80' of new copper telephone cable under 40th Avenue, between Section 28 and 27, Swea Township. This is maintenance work. Permit number 07-08-37 is on file in the Kossuth County Engineer's Office. Ayes 5, Nays 0. Motion carried unanimous.
