**REGULAR MARCH SESSION**

The Board of Supervisors met pursuant to adjournment. Present were: Don McGregor, Chairman, Don Besch, Jack Plathe, Roger Tjarks and Pam Wymore.

Public Discussion was held followed by Discussion with Secondary Road Foreman.

Motion by Tjarks and 2<sup>nd</sup> by Besch to approve the agenda and the minutes of the previous meeting dated March 1, 2016. Motion carried.

Motion by Besch and 2<sup>nd</sup> by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Windstream Iowa Communications, Inc., Little Rock, AR, to complete the relocation of 624 feet of cable within the right of way of 150<sup>th</sup> Avenue along the east side of section 20, Springfield Township. The relocation work is necessary for road and bridge work on 150<sup>th</sup> Avenue, work will involve plowing and a 300' creek bore. Permit number 03-04-2016 is on file in the Kossuth County Engineer's Office. Motion carried.
