Motion by Plathe and 2<sup>nd</sup> by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Algona Municipal Utilities, Algona, IA, to install 2" HDPE conduit by directional drill and backhoe trench for high voltage power line to an existing customer. Work will be at 1408 240<sup>th</sup> Street, approximately 2,800' east of the intersection of 140<sup>th</sup> Avenue and 240<sup>th</sup> Street, between Sections 20 and 29, Plum Creek Township. Permit number 10-27-2016 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Besch and 2<sup>nd</sup> by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Telecom Construction for CenturyLink, Clearwater, MN, to plow 380' of 3 pair 22 gauge copper cable including a bore under 80<sup>th</sup> Avenue to an existing customer. Work will be at 1007 80<sup>th</sup> Avenue, approximately 2,890' south of the intersection of 80<sup>th</sup> Avenue and 110<sup>th</sup> Street, between Sections 31 and 32, Riverdale Township. Permit number 10-28-2016 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Tjarks and 2<sup>nd</sup> by Wymore that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Winnebago Coop Telephone Association, Lake Mills, IA, to plow in a new fiber line. Work will begin in the west right of way of 160<sup>th</sup> Avenue and 428<sup>th</sup> Street, then continue 280' south and crossing 160<sup>th</sup> Avenue to 4208 160<sup>th</sup> Avenue. Work will be in Section 21 and 22 Ledyard Township. Permit number 10-29-2016 is on file in the Kossuth County Engineer's Office. Motion carried.
