

BOARD PROCEEDINGS
February 17, 2017
REGULAR FEBRUARY SESSION

The Board of Supervisors met pursuant to adjournment. Present were: Don McGregor, Chairman, Jack Plathe, and Roger Tjarks. Absent: Pam Wymore and Don Besch.

Motion by Tjarks and 2nd by Plathe to open the meeting for considering Terms for Bargaining Units Agreement. Motion carried. Absent: Wymore and Besch

Motion by Plathe and 2nd by Tjarks to go into closed session per Iowa Code 20.17 (3). Chairman McGregor called for a roll call vote: Wymore: absent, Tjarks: yes, Plathe: yes, Besch: absent, McGregor: yes.

Closed Session – Pam Wymore joined in on conference call at 11:07 a.m.

Motion by Tjarks and 2nd by Plathe to leave closed session per Iowa Code 20.17 (3). Chairman McGregor called for a roll call vote: Wymore: yes, Tjarks: yes, Plathe: yes, Besch: absent, McGregor: yes.

Motion by Tjarks and 2nd by Plathe to accept the tentative Kossuth County Secondary Road Labor Agreement negotiated between Kossuth County and the International Union of Operating Engineer's. The agreement is for a period from July 1, 2018 to June 30, 2020.

Kossuth County and IUOE Local 234 have agreed to extend the expiration of the Secondary Road Agreement to June 30, 2020. All items will remain the same except for the following:

Effective July 1, 2018, increase wage rates by 2.0%

Effective July 1, 2019, increase wage rates by 2.0%

Chairman McGregor called for a roll call vote: Wymore: yes, Tjarks: yes, Plathe: yes, Besch: absent, McGregor: yes

Motion by Plathe and 2nd by Tjarks to accept the tentative Kossuth County Sheriff Labor Agreement negotiated between Kossuth County and the Communications Workers of America, AFL-CIO. The agreement is for a period from July 1, 2018 to June 30, 2020.

Kossuth County and CWA have agreed to extend the expiration of the Sheriff's Office collective bargaining agreement to June 30, 2020. All items will remain the same except for the following:

Effective July 1, 2018, increase wage rates by 2.0%

Effective July 1, 2019, increase wage rates by 2.0%

Chairman McGregor called for a roll call vote: Wymore: yes, Tjarks: yes, Plathe: yes, Besch: absent, McGregor: yes

Motion by Tjarks and 2nd by Plathe to accept the tentative Kossuth County Courthouse Labor Agreement negotiated between Kossuth County and the Courthouse Teamsters Local 238. The agreement is for a period from July 1, 2018 to June 30, 2020.

Kossuth County and Teamsters Local 238 have agreed to extend the expiration of the Courthouse Unit Agreement to June 30, 2020. All items will remain the same except for the following:

Effective July 1, 2018, increase wage rates by 2.0%

Effective July 1, 2019, increase wage rates by 2.0%

Chairman McGregor called for a roll call vote: Wymore: yes, Tjarks: yes, Plathe: yes, Besch: absent, McGregor: yes
