The Board was provided copies of the Local Option Sales Tax transfer that Amber Garman made from the Rural Basic Fund to the Secondary Road Fund in the amount of \$300,000.

The Board was provided copies of the January transfers that Amber Garman made from the General Basic Fund to the Secondary Road Fund in the amount of \$1,278.39 and from the Rural Basic Fund to the Secondary Road Fund in the amount of \$12,978.08. The transfers were made on February 3, 2017.

Drainage was held followed by the Completion and Reclassification Hearing for Improvement of Drainage District 80 Laterals 80, 81 and others and Bid Letting for Open Ditch Cleanout Project for Drainage District 4.

Motion by Besch and 2nd by Plathe that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Interstate Power and Light (Alliant Energy), Spirit Lake, IA, to complete an underground electric line installation and pole removal project.

Work will be completed within the following right of way of Burt Township:

- -310th Street and Highway 169 southeast along 310th Street 1600 feet
- -310th Street between 100th Ave and 115th Ave
- -100th Avenue beginning 1660 feet south of 310th Ave to 320th Ave
- -320th Street and 100th Avenue east to 300 feet east of 115th Avenue
- -115th Avenue then south of 320th Street 2000 feet.
