A transfer was made from the General Basic Fund to the Secondary Road Fund in the amount of \$95,364.11 and from the Rural Basic Fund to the Secondary Road Fund in the amount of \$816,662.91.

Motion by Wymore and 2nd by Tjarks that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to Interstate Power & Light, Spirit Lake, IA, to bore electric in 2" conduit under 340th Street, 2440 feet east of 70th Avenue. Work will be on the south side of Section 32 Greenwood Township and north side of Section 5, Burt Township. Permit number 10-40-2017 is on file in the Kossuth County Engineer's Office. Motion carried.

Motion by Tjarks and 2nd by Plathe that the Board of Supervisors of Kossuth County, Iowa, does hereby authorize and give its permission to John Kurtzleben, Titonka, IA, to install 72 feet of 12" diameter Class 3 reinforced concrete pipe by cutting through 250th Avenue, 1580 feet north of 350th Street. The crossing is subject to approval by Winnebago County. The crossing is on the east side of the Southeast quarter of Section 25, German Township. Work will be in Section 25 German Township, Kossuth County and Section 30 Grant Township, Winneabago County. Permit number 10-41-2017 is on file in the Kossuth County Engineer's Office. Motion carried.
